### 7. GAME DRIVE AND GUIDED WALK POLICY:

- 7.1. Children under 3 years old are not permitted on any game drives, this includes private safari vehicles booked.
- 7.2. Persons under the age of 16 are not permitted on walking safaris.
- 7.3. Persons over the age of 65 will require a medical clearance certificate stating they are fit to partake in a strenuous walking safari lasting up to 4 hours.
- 7.4. Pregnant women are not permitted on walking safaris.
- 7.5. Unmanned Aerial Vehicles: Please be advised that the use of Unmanned Aerial Vehicles (Drones) is not permitted on the reserve, until such time as their impact on wildlife and anti-poaching initiatives can be assessed.
