CHECK-IN/CHECK-OUT:

CHILDREN'S POLICY:

- ❖ Children under the age of 12 are not permitted at the Lodge.
- ❖ Children aged 12 and older are charged 100% of the adult sharing rate.

WILDLIFE ACTIVITY POLICY:

- ❖ Guests of all ages are permitted to join game drives.
- ❖ Guests aged 16 years and older are permitted on bush walks outside the Lodge.
- ❖ Participation in game drives and nature walks is always at the discretion of the ranger, regardless of age. This is for the safety of all guests and staff.

**PAYMENTS:**

- ❖ Reservations must be guaranteed within 14 days of booking. If the booking is made within 45 days of arrival, it must be guaranteed within 72 hours.
- ❖ To guarantee your reservation a 25% deposit is payable.
- ❖ Full payment is required 30 days prior to arrival.
- ❖ All major credit cards are accepted.

CANCELLATION POLICY:

- ❖ For exclusive-use bookings, cancellations made 0–60 days prior to arrival will incur a 100% cancellation fee.
- ❖ All no-shows will be charged 100% of the booked value.
