

#### **VENUE SIZE**

4 600 sqm property

#### CAPACITY

150 pax cocktail style 80 pax maximum seated dinner

#### POWER

Standard household. No generator is provided, client must bring in additional power as required.

#### KITCHEN FACILITIES

The villa has an open plan kitchen with a hidden scullery available for caterers on site.

It comes with standard cooking equipment, anything additional is for the client's own account.

#### SOUND/MUSIC

The venue does not provide any sound equipment, this must all be brought in by the client.

The villa has an internal surround sound system using SONOS. The system is connected to Apple Music, SoundCloud, Spotify, Tidal etc. and can be used by the clients/event-coordinator during the event.

There is an Otto Bach Grand piano also available for use.



#### LIQUOR LICENSING & BAR

As we are a private villa in a residential area we can only accept events that are private.

All alcohol and beverages must be provided by the event organiser/client and alcohol cannot be sold to guests attending the event.

#### **BATHROOM FACILITIES**

There are 3 bathroom facilities available and no disabled bathrooms.

#### SECURITY DURING EVENT

Moondance Villa will provide a security guard for the duration of the event at no extra cost as we would like a secure and safe environment for guests and clients to enjoy themselves.

#### PARKING

There is minimum parking permitted at the venue and on the surrounding streets - guests must either use Uber or shuttles.



- No use of the top floor for event bookings
- No use of the bedrooms for event bookings
- No use of the showers for event bookings
- No towels will be provided for event bookings
- No smoking inside the venue outside only
- A detailed event / production schedule with all supplier's details, load in and out times must be supplied to the venue manager
- Music / Sound: Moondance is a private residence in a built up area, please be considerate of the neighbours
- The maximum level of sound in the venue is 85-90 db
- Music must be off and bars closed at 00:00 unless expressly agreed to in writing between the venue management and client
- The venue closes at 2am sharp for all events
- No loitering on the street after leaving the venue.







A Damages Deposit will be required for all event bookings and can go up to R150 000 for events over 50 people. The damages deposit is determined by the nature of the event and the number of people coming in and out of the villa. The property owner and its managers have the sole discretion to value the deposit required.

- Should there be any damage to either the venue or its contents during an event, the client (person/s hiring the venue) will be held responsible
- Confirmation of an event serves to confirm that any damage will be repaired or replaced without question by the client within a 7-day period after the event upon receipt of written request to do so
- Guests attend Moondance Villa at their own risk
- Neither the owner of Moondance Villa, its managers, agents, employees or assigns shall be held liable for any theft, injury, loss or damage of whatever nature, and the client and guests hereby waive any claims that may arise against any of the aforementioned parties, whether arising from Moondance's default, negligence or otherwise
