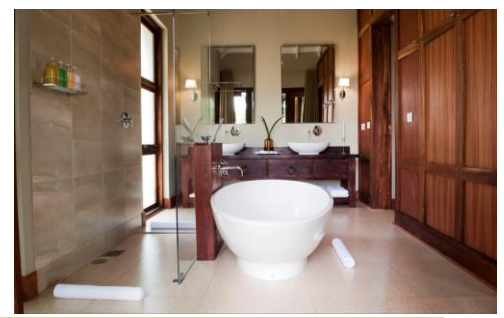

TERMS AND CONDITIONS

RATES

All rates are quoted in US Dollars. The rates quoted are strictly confidential and may not be divulged to any third party. Any breach thereof may result in rates being withdrawn. All prices are inclusive of Bed & Breakfast, VAT, and Government Taxes. Prices are subject to change without notice, if beyond our control.

BOOKINGS

Bookings will be held provisionally on receipt of a voucher or an email. Bookings will be confirmed upon receipt of a 20% non-refundable deposit, payable within 14 days after the invoice is issued, typically via bank transfer or credit card as specified on your invoice.

PROVISIONAL BOOKINGS

Provisional bookings made 60 or more days from arrival will be held for 14 days.
Provisional bookings made less than 60 days from arrival will be held for 7 days.

PAYMENTS

Full payment is required 30 days prior to the date of arrival.

AMENDMENT POLICY

For booking changes made 30 days or more prior to arrival, 100% of the total booking cost must be paid before we can confirm the change of dates. Date changes are subject to availability and any rate differences for the new dates.

CANCELLATION AND REDUCTION POLICY

For bookings reduced in numbers or in length of stay or fully cancelled between 30 and 15 days from the date of arrival, 50% of the applicable rate per room will be charged.

For bookings reduced in numbers or length of stay or fully cancelled between 14 and 7 days before the date of arrival, 75% of the applicable rate per room will be charged.

For bookings reduced in numbers or length of stay or fully cancelled within 7 days from the date of arrival and for all "No Show" guests, 100% of the applicable rate per room will be charged.

All cancellations are to be made in writing.

FORCE MAJEURE

Neither party shall be liable for any failure or delay in performing its obligations under this policy if such failure or delay is caused by circumstances beyond its reasonable control, including but not limited to acts of God, war, terrorism, government regulations, natural disasters, or pandemics. In such cases, the parties will work together in good faith to find an amicable solution, which may include rescheduling the booking or issuing a credit for a future stay.
