Have a bath in our handmade tin tub, go out on a game cruise instead of a game drive and enjoy a water safari. For authenticity in the wilderness, Honey Bear ticks all the boxes.

## PAYMENT & DEPOSIT POLICY

All payments must be received in FULL i.e. NET of any charges.

Upon confirmation, a 30% non-refundable and non-transferable deposit is required to fully guarantee the booking.

The final balance of 70% is due 45 days prior to the date of arrival.

Bookings made within 45 days of arrival - full payment is due upon receipt of an invoice.
