**CHECK IN TIME** is 60 minutes before flight time in Nairobi (Wilson), Kilimanjaro, Kisumu and Entebbe Airports. Gate closes 30 minutes before departure time after which passengers will not be allowed to check in. Check in time from all bush airstrips is 30 minutes before departure time. CANCELLATIONS & NO SHOW POLICY:

- Above 10 days before date of travel: \$ 50 cancelation fee per ticket if tickets have been issued.
- Between 9 to 5 days before date of travel: \$ 100 cancellation fee per ticket will apply.
- Cancellation within 4 days to date of travel: NO refund, NO-SHOWS..

No-SHOW Tickets are not transferable and are non - refundable. These tickets are valid for six months at a revalidation fee of \$ 100 per ticket on availability basis.In the event of exceptional or humanitarian circumstances or for Passengers who are unable to travel for health reasons, a request for refund would be considered on an individual basis and will be granted at the company's discretion.

All refunds will be subject to administrative fees of USD 20 per ticket, 5% PSP commissions where card payments have been processed and bank charges where bank transfers are required. These will be deducted from the refund.

In all cases refunds will be paid within 45 days from date of cancellation.

AMENDMENT POLICY:
