

Terms and Conditions

Of my own free will and fully aware, I hereby state, with reference to my participation in the itinerary and date chosen by me, promoted by **Dutchman Adventure**, that I am aware of and agree to the following terms:

To confirm the reservation, an advance payment of **USD 200.00 per person** will be charged, which will be converted into Brazilian reais and can be paid via credit card or PIX. Sixty (60) days before the trip, an additional transfer of **USD 300.00 per person via WISE** will be requested. *The remaining amount must be paid in USD, in cash, on the day of departure of the itinerary.*

The package price does not include bike rental. After the reservation is confirmed, a form will be sent by email for each participant to indicate whether they wish to rent a bike. Payment must be made in cash on site, on the day of departure of the itinerary.

I declare that I have read, understood, and agree with all the information contained in the Manual on safety, fitness, and personal responsibility (a mandatory reading item during registration and booking), which was previously provided by the event organization in the document attached to this term.

I am aware that I must possess all documents essential for travel, such as a passport (minimum validity of 6 months) and visa (if required), and that personal travel insurance is mandatory to cover potential health expenses or unforeseen circumstances that may cause interruption or cancellation of the trip.

I am further aware and agree that if I cancel any of the purchased packages within 60 days or less before the trip, **THE ADVANCE PAYMENT WILL NOT BE REFUNDABLE**, as it is used to guarantee my spot with our partners and contractors. In cases of cancellation more than 60 days before the trip, the amount paid at the start of booking (**USD 200 per person**) may be held as a credit for up to 2 years to be used for a future trip with **Dutchman Adventure**.

I am aware that **Dutchman Adventure** works with various agents to sell its tours, which take place in international territory, and for this reason, payment must be made in the currency of the country where the tour will take place (dollar or another indicated currency).

I acknowledge the risks normally inherent in a cycling trip (bike tourism) in another country and agree to be as prudent as possible, following the rules and guidance provided by the organization, assuming full responsibility for any moral, physical, and/or material damages I may cause to third parties or suffer myself as a result of my conduct, both in civil and criminal spheres, including in the country visited.

I am also aware that, if necessary, and according to the terms of the travel insurance I contracted for this purpose, as well as local health care rules in the visited country, medical care and/or first aid may be provided, but it will always depend on the location and conditions I am in, and the organizers, guides, and sponsors cannot be held responsible for any unforeseen events or local difficulties.

I understand the importance of being in good health and declare for all purposes that I am technically, physically, and psychologically fit to participate in the routes and activities included in the cycling itinerary I have chosen, affirming that I have no medical restrictions that prevent me from doing so.

I am aware and agree that the organization reserves the right to postpone, cancel, or modify the activity at any time without prior notice due to weather, safety, or force majeure reasons, and in such cases, no refund or reimbursement of expenses for transportation, accommodation, meals, and/or tickets will be provided.

I agree and authorize the event organization, as well as sponsors and supporters, to use any images in which I may appear, produced during the event (photographs, videos, testimonials, etc.), for promotional and/or advertising purposes, at no cost or liability to them.

Therefore, having received all information from the website, WhatsApp group, Safety, Fitness, and Personal Responsibility Manual, as well as the information in this document, I agree to release **Dutchman Adventure** from liability for acts and omissions that are not directly related to the service provided, as well as for acts and/or omissions committed by any partners/contractors who fail to fulfill their contractual obligations.

I have carefully read all the above terms and am aware that this document governs my rights and responsibilities, and, consequently, I sign it of my own free will. (In the case of participants under 18 years old, this agreement must be signed by the legal guardian who will accompany them throughout the trip.)
