I,herewith agree,	to comply and adhere to the following:
This agreement is binding to the rental contract	signed by the renter.
 SPEED LIMITATIONS: 60km/h in town 60km/h for all 2x4 vehicles on gravel/salt- and sand roads 80km/h for all 2x4 vehicles on gravel/salt- and sand roads 120 km/h on tarred roads INSURANCE COVER: The Insurance ONLY applies in case of a collision with another moving objet (e.g. vehicle, animal or human) In case of a collision with another vehicle, animal or theft of the car the Exce authorised by Credit Card will be subtracted immediately, from the rente credit card. In this case (if all given procedures have been followed) the ren will be liable up to the excess amount. This only applies if the renter was in breach of contract. The Contract is herewith cancelled and the rest of rental will NOT be paid back OR used for the new exchange car which will Not necessarily be delivered if the Rental Company chooses not to do so whater the circumstances may be. In case the rental company decides to deliver an exchange vehicle, a nexcess (not reduceable anymore) plus the new rent must be paid or subtract from the Credit Card BEFORE the car will be delivered to the renter. In case the renter is in breach of the Rental contract the rental company will hold the renter liable for an Excess N\$ 140,000.00. Should the Insurance decide not to pay, due to extreme negligent driving (example) the renter will be held liable for the full loss / damage of the vehicle a after costs occuring, which can be up to N\$ 400 000 depending on the categot. Single Vehicle Accidents: Not covered by any insurance. Bumping a tree/p while reversing the car, accidents without a collision involving a moving object (animal, person or vehicle) are single vehicle accidents, and the client will be heliable for N\$ 140 000, plus all recovery costs. Losing control over	damage to the police within 24hrs. It is the renter's responsibility to provide Autovermietung Savanna with a copy of the Accident Report and Accident Report Number received at the police station, otherwise NO insurance cover will apply, and the renter will be held liable for the full repair of any damages to the vehicle. In this case the excess chosen will no longer be valid and the renter will be liable for the total cost of repair or replacement due to any damages 8. It is very important that the FOUR – WHEEL DRIVE is de-activated before driving on a hard surface (tarred/gravel roads), as this can cause damage to the drive-train. This is considered as excessive wear and tear and is not covered by the insurance. 9. Clutch and under body damages are NOT COVERED by any insurance and will be on the Renters account. (Under body damage is only covered by Excess Insurance Option 4) • In the event of clutch damage, the following steps will apply: i. The basic fee of N§15,000.00 will be deducted from the Credit Card before any replacement vehicle is sent (N§25,000.00 when outside Namibia) iii. The replacement vehicle will not be handed over to the renter if all the documents are not signed. iii. The fees mentioned above will not be the final calculation as this can only be determined once the vehicle has been recovered and all costs have been finalized 10. Lost, stolen or damaged rims are NOT COVERED by any insurance and will be on the Renters account. The renter agrees to the Terms and Conditions by signing all the Documents provided by Autovermietung Savanna. 11. No Tyre Damage will be refunded unless the renter paid for the Tyre and Windscreen Insurance upon vehicle pick up. The renter is therefore fully liable for any Tyre and Rim damage. The renter will be liable for the total cost of a new Rim and a new Tyre. Two completely damaged Tyres are included in the Tyre and Windscreen Insurance (rim damage is not covered by any insurance). 12. Any damages caused by EXCESSIVE WEAR AND TEAR by the renter, are n
